

• Tax benefit

Eligibility for Gimje Free trade Zone

• Those who meet the occupancy requirements for the zone according to Article 10 of Act on Designation and Management of Free Trade Zone

Manufacturing business primarily for exports	Business which amount of export is at least 50/100(30/100 in cases of small and medium enterprises, 40/100 in cases of middle-standing enterprises) of the total sales during the past 3 years from the date on which an application for an occupancy contract is filed, for at least 1 year in a low
Foreign iinvested enterprise (manufacturing business)	Business which satisfies the standard of the foreigner investment of ₩100million and also owns 10% of either the total number of stocks or the total sum of investors issued by corporations or companies run by the people of the Republic of Korea

 Consultation on the occupancy → Applying for occupancy → Making the occupancy agreement → Making the lease agreement

Expressway

- Saemangeum Pohang Expressway(planned to be completed in 2020)
- Seohaean Expressway(taking 1 hour and 30 minutes)
- Suncheon-Wanju Expressway(taking 2 hours)

Railway

- KTX and SRT Honam line(Iksan station) : 1 hour between Seoul and Gimje
- * Time taken between Gimje Free trade Zone and Iksan station
 : 15 minutes

Harbors

- Gunsan Port : 35 berths for the ship of 50,000 ton max
- * Time taken between Gimje Free trade Zone and Gunsan Port :
 20 minutes
- Saemangeum New Port : 18 berths for the cruise ship of 80,000 ton(planned to be completed in 2030, 4 berths would be first completed by 2020)
- * Time taken between Gimje Free Trade Zone and Saemangeum New Port : 20 minutes(if Saemangeum-Pohang Expressway is completed)

Benefits for the foreign-invested company

• Minimized investment cost with the exceptional low rent

- In Gimje Free Trade Zone, the authority provides the companies with the land and buildings owned by the nation at the price equivalent to 1% of the officially assessed price for 50 years. As the investor needs not to purchase the land, the initial investment cost can be reduced a lot.
 - Monthly rent of land for the factory : $0.06/m^2$
 - Monthly rent for the apartment type standard factory : \$ 0.42/m²

Deregulation for guaranteeing the trading activities

- Deference of tax for imported materials
 - It applies when the facility, raw materials or building materials are imported from overseas for the business
- Permission of off-shore work
 - Some of the processes for manufacturing the product can be processed at the domestic bonded area
 - The foreign materials such as facilities which are required for processing can be shipped overseas in the bonded state.
- Application of zero tax for VAT
 - Foreign products and services which are supplied or provided between companies in the free trade zones
 - Materials for export which are delivered from other area of Korea
